

Babylon the Great (1 of 40) – Introduction

Nimrod means ‘rebellion’ in Hebrew. Nimrod’s rebellion is the recreation of the world government of Lucifer, and of the Luciferian ideology. The Luciferian religions are celebrations of Lucifer’s reign on Earth, and of Nimrod’s attempt to recreate it. Lucifer ruled from Egypt; Nimrod from Babylon.

Jerusalem was designated by Almighty God as the spiritual and political capital of the world for all those who have resisted the Luciferian ideology, both before and after the Israelites began to occupy Palestine.

God, the creator of the whole universe determined the exact placement and measurements of the temple which housed the Ark of his Covenant with Abraham and the Israelites (Ezekiel 43:12, 1 Chronicles 28:11-19).

The gods who descended to Earth in Palestine resided in the Sumerian religious center of Nippur (origin of the name Nibiru). Their central administrative authority was at Giza in Egypt, and the Bible makes it clear that Babylon (as the new Sumer) was the commercial center of the world (Revelation 17-18). The term “Babylon” is applied in prophetic scripture to denote the one-world ecclesiastical, financial and political ambitions of the Illuminati and Freemasons in direct opposition to Jerusalem.

The pyramids of Egypt and the ziggurats of Babylon (as well as those of other ancient civilizations) were built as landing platforms for the gods, surrounded by four pillars which have subsequently fallen or been stripped away. The domes and stained-glass windows of Roman churches and cathedrals represent flying saucers. The four pillars surrounding Muslim mosques represent landing pillars. Nimrod’s rebellion continues. Then, as now, the “chosen” nation of the Hebrews has opposed it. Then, as now, the city of Jerusalem is the center of the conflict.

The vision of Daniel 2 depicts the image of a statue with a head of gold, a chest and arms of silver, a belly and thighs of bronze, legs of iron, and feet of iron mixed with clay. This image represents the historical succession of civilizations which ruled over Palestine from the time of Daniel to the time Israel’s dispersion, and also during the present time.

The head of gold represents Babylon.

The chest of silver represents Persia.

The legs of iron represent Macedon or Greece

The feet of iron represent Rome, and the mixture of clay represents the revived Roman Empire (the European Union), or the realization of the ambition of world government which the Romans inherited (the United Nations).

The two legs represent the division between Alexander the Great’s successors, between the Caesars and the Senate and the people of Rome, and between the Eastern and Western Roman Empires.

In Daniel’s vision, a stone smashes the image and becomes a great mountain. This stone represents the remnant of Israel, i.e. the tribe of Dan. Rome’s power was shattered by the Vandals and Goths, descendants of the tribe of Dan, who became the ancestors of the Western European nations. It is this remnant which has reorganized the ancient Roman Empire.

Now there are three cities within the revived Roman Empire which have served as centers of power for the remnant of the Illuminati inspired by Nimrod. The financial and political apparatus of the whole world is administered through these three centers. The three centers of power are the City of London,

the Vatican City-State in Rome, and the District of Columbia in Washington. These three districts are completely independent of any domestic or international government influence.

The Vatican does not belong to Rome, nor to the Republic of Italy, nor even to the European Union. It is a sovereign, independent nation, ruled by the Holy See, which is and always has been the ecclesiastical authority of the Roman Catholic Church and of the ecumenical movement. It is the veritable power behind the New Age Movement. The Vatican is therefore the spiritual capital of the world, as Nippur once was.

The City of London does not belong to the queen of the United Kingdom, nor to its people or parliament. It belongs to the British Crown, which possesses the financial district of London and exists completely independently of the parliaments and monarchies of the world, which it controls through the means of corporate commercial transaction, debt and inflation. The City of London is therefore the financial capital of the world, as Babylon once was.

The District of Columbia is not under the jurisdiction of the President, the legislature, the citizens or any of the states of the United States. It has its own laws and law enforcement agencies, chartered by executive orders, which are letters of marque to commandeer the world's resources on behalf of the Church and the Crown (i.e. it is both legally and actually in a declared state of war with the citizens of the United States of America, and of the world). Washington's District of Columbia is therefore the administrative capital of the world, as Giza or Saqqara once was.

Babylon the Great (2 of 40) – Sacred Geometry

Nautical distances exist in nature and are used for navigational purposes. They measure degrees of an arc. 1 knot = 1 nautical mile per hour. The etymological origin for 'nautical,' 'navy,' 'navigation,' etc. is the Greek *naus*, from the Hebrew *naw-veh* or *no-ah*, meaning 'rest,' 'home,' or 'temple.' *Naus* is the Greek for the Holy of Holies, or the Most Holy place of the Temple in Jerusalem. Noah's Ark is the arc of navigation. The nautical mile is the ark mile, measured against the position of the Temple Mount.

Statute miles have had prophetic significance before the time of Christ (BC). Nautical miles have had prophetic significance since the time of Christ (AD). The statute mile was created by measuring the sacred cubit (25.20 modern inches) used in the design of Solomon's Temple. There are 63,360 inches (5,280 feet, or 1,760 yards) in a statute mile.

25.20 is sacred because it is a fractal of 2,520. As the product of 7 (the number of completion) and 360 (the number of degrees in a circle), 2,520 is the most important number in Biblical prophecy and numerology. It is the number of the writing on the wall in the book of Daniel. It was used with 7 and 360 to create the dimensions of Earth and its moon.

The common cubit is 21.60 inches. 21.60 is a fractal of 21,600, the circumference of Earth in nautical miles (360 degrees x 60 minutes). The diameter of Earth is $2,520 \times \pi$ in statute miles. The apogee (the greatest distance of the moon from Earth) is 252,000 statute miles ($2,520 \times 100$).

The burial place of Moses on Mt. Nebo is 25.20 nautical miles due east of Jerusalem's Temple Mount. The terminus is 1,260 ($2,520 \div 2$) feet above sea level. The Temple Mount itself is 2,520 feet above sea level.

2,520 is also half of 5,040, which was held to be sacred in the ancient world. Eratosthenes (c. 200 BC) measured Earth's circumference at 250,000 stadia by calculating the degrees between Syene and Alexandria. He was only 287 miles short. The distance from Syene to Alexandria is 5,040 stadia.

The Babylonians captured Jerusalem in 587 BC. Babylon was captured by the Persians in 539 BC. Nippur is 587 statute miles from Jerusalem, and Babylon is 539 statute miles from Jerusalem. The Kab'ah stone in Mecca is precisely 666 nautical miles from the Temple Mount.

In the vision of Revelation 16:13, three unclean spirits like frogs spew out of the mouths of the dragon, the beast, and the false prophet. The Lateran Palace is the Holy See. It was built by the Roman emperor Nero, who made a frog his designated heir. *Lateran* means 'hidden frog.' Rome's historic center, as marked by the Lateran obelisk, is 2,520,000 yards from the Temple Mount foundation stone in Jerusalem.

London was built by the Roman emperor Claudius. The milestone of the ancient city center is 1,948 nautical miles from the Temple Mount. This corresponds to the recognition of the modern state of Israel after the British withdrawal from Palestine. Israel's statehood happened 2,520 prophetic (360 day) years after the fall of Babylon and the return of the Judeans to Palestine in 539 BC, minus the 33 years of Christ's life on earth.

The laws and the governments of the United States and the French Republic were based entirely on Plato's *Laws*. *Laws* is a draft for a constitution which was adopted by the Confederation Congress as the US was becoming an independent nation. The original Confederation Congress convened at

Philadelphia, in reference to Plato's idealism and to Freemasonry's influence. After the American Revolutionary War the Congress was moved to New York, which was effectively the new capitol of the US.

In *Laws* Plato calls 5040 "the greatest order of all numbers."

The Statue of Liberty in New York Harbor is 5,760 (5040 + 666) nautical miles from the Temple Mount. It was constructed and given by French Masons who built an identical one in France, and who prior to its construction had sought a commission for a giant statue of Isis to overlook the Suez Canal based on the Colossus of Rhodes which depicted the sun-god Helios. The torch was originally intended to be a cup, but neither France nor America had any claim to the Whore of Babylon status of the Church and Crown.

The American capitol of Washington D.C. was founded in 1790. The Federal Capitol building lies on the 77th meridian at 00' 33" longitude, 38° 53' 25" latitude. 38.5 is half of 77. The Washington Monument (the world's largest obelisk) is 555 feet (6,660 inches) tall. It is 5133.33 (77 × 66.666) nautical miles from the Temple Mount.

Napoleon made a proclamation for a sovereign Jewish state in 1799. The center of Paris is 1799 nautical miles from the Temple Mount.

[Revelation 16:13-14, 16, 19-20] And I saw three unclean spirits like frogs come out of the mouth of the dragon, and out of the mouth of the beast, and out of the mouth of the false prophet. For they are the spirits of devils, working miracles, which go forth unto the kings of the earth and of the whole world, to gather them to the battle of that great day of God Almighty ... And he gathered them together into a place called in the Hebrew tongue Armageddon ... And the great city was divided into three parts, and the cities of the nations fell: and great Babylon came in remembrance before God, to give unto her the cup of the wine of the fierceness of his wrath. And every **[nation]** fled away, and the **[governments]** were not found.

[Revelation 17:1-5] I will shew unto thee the judgment of the great whore that sitteth upon many waters: With whom the kings of the earth have committed fornication, and the inhabitants of the earth have been made drunk with the wine of her fornication ... I saw **[the Catholic Church]** sit upon **[the Roman Empire]**, full of names of blasphemy, having seven heads and ten horns. And the woman was arrayed in purple and scarlet colour, and decked with gold and precious stones and pearls, having a

golden cup in her hand full of abominations and filthiness of her fornication: And upon her forehead was a name written, MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND ABOMINATIONS OF THE EARTH.

Babylon the Great (3 of 40) – The Temple

Jerusalem means ‘city of peace.’ At the time of the Israelites’ conquest of Palestine it was called Jebus. *Jebus* means ‘threshing floor’ and is a reference to crop circles. Jerusalem was the archetype and image of the kingdom of heaven on Earth (Hebrews 11:8-11). Its numerological value in Hebrew is 1146 ($365 \times \pi$). Ezekiel began prophesying the fall of Jerusalem (which occurred in 587 BC) near Nippur, 587 statute miles from Jerusalem. Ezekiel’s prophecy against Jerusalem was in response to the priests’ turning away from the Temple to worship the sun (Ezekiel 8:16), i.e. Babylon-inspired rebellion. So the Babylonian apostasy of the Judeans began before they were carried off to Babylon and became Jews.

The prophet Jeremiah took the Temple treasures (including the Ark of the Covenant) out of the Temple to hide it from the Babylonians and Jews. According to the Talmud, he threw the keys of the Temple and its sanctuary at the sun. It has been the avowed object of the Zionists to rebuild the Temple and restore Judea to its former glory ever since.

The “square script” of the Aramaic alphabet was adopted from written Hebrew during the Babylonian exile. Although they were always evil and wicked, this is when the apostate Judeans became irreconcilable to God as Jews. Only a few had been sealed as mourners over Judea’s idolatry.

King Cyrus of Persia married the Jewess Esther and was sympathetic to the Jews. With his permission the Jew Zerubbabel (‘Seed of Babel’) led a band of Jews into Palestine which was already occupied by their Israelite cousins and began rebuilding the Temple the following year. The wicked Edomite King Herod continued expanding it five centuries later.

A second rebuilding of the Temple was prophesied by Ezekiel, Isaiah, Amos, Micah, Tobit and others, even before the Temple of Zerubbabel and Herod was destroyed. John prophesied it from his exile on the island of Patmos, which is 539.86 nautical miles from the Temple mount. $7 \times 77 = 539$ There are 49 (7×7) years between the early calculation and the late calculation of the return of the exiles. There were 657 years (to the day) between the destruction of Solomon’s Temple and the destruction of Zerubbabel’s Temple. In prophetic (360-day) years, this is 666. There were also 17,640 ($360 \times 7 \times 7$) days between the destruction of Solomon’s Temple and the fall of Babylon.

[Daniel 7:25] And he shall speak great words against the most High, and shall wear out the saints of the most High, and think to change times and laws: and they shall be given into his hand until a time and times and the dividing of time.

[Daniel 12:7] And I heard the man clothed in linen, which was upon the waters of the river, when he held up his right hand and his left hand unto heaven, and sware by him that liveth for ever that it shall be for a time, times, and an half; and when he shall have accomplished to scatter the power of the holy people, all these things shall be finished.

[Revelation 12:14] And to the woman were given two wings of a great eagle, that she might fly into the wilderness, into her place, where she is nourished for a time, and times, and half a time, from the face of the serpent.

Daniel’s “time, times and half a time”:

1st = Solomon’s Temple (966 – 586 BC)

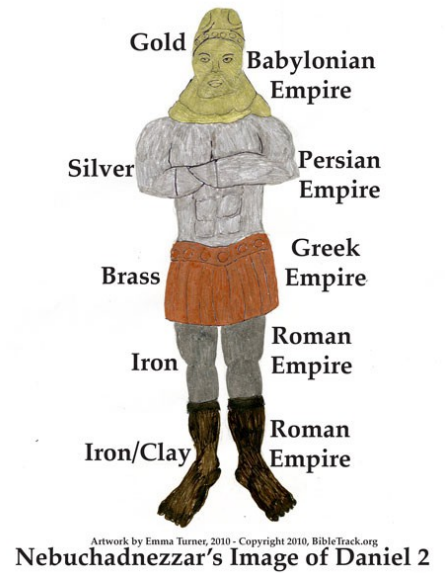
2nd = Zerubbabel’s Temple (537 BC – 70 AD)

“half time” = the Third Temple period

The Assyrian Empire lasted 666 years before it was conquered by Babylon. The Roman Empire controlled Jerusalem for 666 years (counted between the Battle of Actium in 31 BC and the Saracen conquest in 636 AD).

Only Almighty God has the power and authority to build the Temple, whenever and however he sees fit. To do it without his permission is to contravene the perfect will of God. Anything less than perfection for his house is an abomination; any people who reside on his holy mountain but do not do his will are a nation of deceivers and blasphemers.

Babylon the Great (4 of 40) – The Jews



Christians do not know how to interpret this vision because they do not know the history of Israel and do not have the spirit of prophecy. They will tell you that the bronze thighs and belly represent Greece, that the iron legs represent Rome, and that the feet of iron and clay represent the revived Roman Empire. This is wrong.



They will say this because they don't want to admit that there is only one Roman occupation of Palestine depicted in the vision, which undermines the Roman, neo-Babylonian religion of Christianity. If this was not the case, or if the Christians weren't worshiping the Persian Mithras, then Daniel would have written of a fifth metal rather than iron.

Rome never ruled over Jerusalem until its demise, and the Greeks did not conquer Palestine before conquering Persia in 332 BC. After butchering the entire male populations of Tyre and Gaza and selling all the women and children into slavery, the Macedonian army under Alexander the Great came to Jerusalem and walked in through the open gates. The Jews showed him the prophecy of Daniel's vision

and claimed he would go on to subdue the Persian Empire. Alexander left Jerusalem in peace, under Greek rule.

So it was the Jews who have given Christians the erroneous interpretation of the vision, and history would seem to indicate they were right; however, the Persians had only actually ruled over Palestine for 34 years. The Talmud (*Ab. Zarah* 86) attests to this. There was another civilization in Daniel's vision between the rule of the Persians and the Greeks, just as Tyre and Gaza were not under Persian rule when Alexander's army captured them.

Unlike the other metals in the vision, bronze is an alloy, a composite of two metals. Israel and Judea were governed by the Pharisees and the Sadducees between the rule of the Persians and the Greeks. The Pharisees and the Sadducees were a Babylonian civilization, just like every other civilization depicted in Daniel's vision. More than a historical account of which kingdom ruled over Palestine, the vision represents a succession of the Babylonian ideology. The Israelites even mixed their bloodlines with the Babylonians during the captivity (Ezra 9:1-2). This is especially true of the leaders of those who returned, including the sons of the priests of Zerubbabel's Temple (Ezra 10:11-23).

The returning exiles were so ignorant of the Israelite culture that Ezra had to read the Law to them. All they knew was the Babylonian oral tradition which became the Talmud. Ezra's recitation of the Law only reinforced their legalism; it did not cause them to repent or turn to Yahweh. The Jews were so hostile to the Israelites and the prophets of Yahweh that they convened the Great Assembly to assert their authority over Judea. The Talmud claims that the Assembly convened as early as the return of the exiles, and even claims (*Neh. viii*) that Ezra himself was their leader.

The Talmud (*Yoma* 9b) claims that the prophetic spirit disappeared from the Jewish people after the later prophets died. Rather than returning to the laws of the Most High and the traditions of their ancestors, the Jews have used this fact to justify the composition of the Talmud in opposition to the Law and the Prophets. Having been so spiritually depraved that they were bereft of their God-appointed leaders, they were forced to rely on their own authority to interpret the laws of God. Rashi (*Megillah* 3a) even claims that Daniel was not a prophet. However, this amounts to nothing more than the Babylonian rebellion spread to the hardened hearts of the former nation of Israel. Herod the Great even went so far as to appoint a Babylonian as high priest. We all know that there were still prophets during the exile in Babylon (Daniel, Ezekiel, Obadiah, Jeremiah) and that the Jews just refused to listen to them, even as they still refuse.

[Matthew 15:1-3] Then came to Jesus scribes and Pharisees, which were of Jerusalem, saying, Why do thy disciples transgress the tradition of the elders? for they wash not their hands when they eat bread. But he answered and said unto them, Why do ye also transgress the commandment of God by your tradition?

[Matthew 15:7-9] Ye hypocrites, well did Isaiah prophesy of you, saying,

“This people draweth nigh unto me with their mouth, and honoureth me with their lips; but their heart is far from me. But in vain they do worship me, teaching for doctrines the commandments of men.”

[Isaiah 65:15] And ye shall leave your name for a curse unto my chosen: for the Sovereign Yahweh shall slay thee, and call his servants by another name

[Revelation 2:9] I know the blasphemy of them which say they are Judeans, and are not, but are the synagogue of Satan.

Knesset = Assembly

Beit Knesset = Synagogue, house of assembly

The Jews in Palestine still refer to their parliament as the Great Assembly.

[John 15:23] He who hates me hates my Father as well.

Babylon the Great (6 of 40) – The Antichrist

The apostles regarded Nero as the Antichrist and the incarnation of Satan in his own time. Peter and Paul were both martyred in Rome under the direct orders of Nero. This is the basis of the Roman bishops' claim of apostolic succession. As emperor, Nero was the *pontifex maximus* or pope of Rome, and by putting Peter to death, he claimed the authority given to Peter and passed it to all succeeding pontiffs. The title of *pontifex maximus* means 'supreme bridge-builder,' which has not lost its esoteric meaning as 'vicar of Christ,' or 'antichrist' (in the place of Christ). But the papacy was the veritable Antichrist long before Nero. It was established by Numa Pompilius, Rome's second king, who founded the *Collegium Pontificum* (College of Pontiffs, now called the College of Cardinals) and the *Comitia Calata* (Calate Assembly), the secret society of patrician priests which governed Rome in secret.

The *Comitia Calata* was comprised of the pontiffs (bishops), the flamines (priests) who offered the daily sacrifices to 15 gods, and the Vestal Virgins who presided over the eternal flame in the Temple of Vesta. The *flamen dialis* was the priest of Jupiter and the second most important office after the *pontifex maximus*. Numa invested the powers of both the *pontifex maximus* and the *flamen dialis* in himself. So the first pope was also the priest of Jupiter and the king of Rome, and he built several temples to Jupiter in Rome. The monarchs maintained the office of *pontifex maximus* for two centuries, until the monarchy was overthrown in 509 BC. From then on the position was awarded by the Roman Senate until it was given to Julius Caesar, and then each of the Roman emperors beginning with Caesar Augustus.

The state religion of Roman Catholicism effectively began during the reign of Augustus, who merged the office of the *pontifex maximus* with the old authority of the Roman kings after five centuries of dormancy under the Senate's supervision, and imported foreign gods to create a new universal religion. This demonstrated most clearly by Augustus' incorporation of the Egyptian motifs into the state building projects, and by the building of the Pantheon ('all gods') by Marcus Vipsanius Agrippa who wielded the real power of the empire in Augustus' name.

Agrippa was responsible for all of Augustus' military victories, including the defeat of Antony and Cleopatra at the Battle of Actium. He was the same age as Augustus and married Augustus' only natural child Julia. Marcus Agrippa and Julia had three children together by 16 BC: Gaius Caesar, Vipsania Julia and Lucius Caesar. Augustus adopted both of his grandsons. After the birth of Lucius the succession seemed absurd, so the couple began to travel. They visited Eastern provinces where they befriended Herod the Great before returning to Italy. However, Gaius and Lucius both died before Augustus.

Another daughter Agrippina was born to Marcus and Julia, and finally another son to carry on the family name was born to them after Marcus' death in 12 BC. He was named Marcus Julius Agrippa, or Agrippa Posthumus. Immediately after his birth, while Julia was still in mourning, Augustus made the biggest mistake of his life. Thinking it was in the best interest of the dynasty, Augustus adopted both Agrippa and Tiberius, who was married to Marcus Agrippa's other daughter from a previous marriage, and married Julia to Tiberius. Neither was happy with the arrangement. Tiberius was forced to divorce his wife whom he loved dearly, and before long Julia was exiled to the island of Ventotene.

The only natural male offspring of Augustus, Agrippa was also later exiled to the island of Pianosa to secure the dynastic succession for Tiberius. During the last year of his reign, Augustus visited his grandson at his prison under a thick veil of secrecy, accompanied by a trusted friend who was later murdered for disclosing the secret to his wife who told Tiberius' new wife Livia. When Tiberius learned

about Augustus' plan to restore Agrippa, the emperor staged a mock execution to save his life, and he was secretly carted off to the furthest realm of the empire: Judea.

Agrippa was adopted by Aristobulus, a son of the family friend Herod, but was later arrested and forced to flee to Alexandria. From there he made his way to Italy and was received by his cousin Caligula, but imprisoned by Tiberius for treason. When Tiberius died, Caligula became the new emperor. Agrippa was set free and made the king of Galilee.

Caligula murdered all of his potential rivals, making Agrippa the only legitimate heir once again, but was assassinated before long. Agrippa was given Judea and Samaria for assisting the new emperor Claudius. Ironically, Agrippa sought the death of Peter who was released from his prison by an angel, and was in turn slain for his blasphemy after ruling over Judea for only three years.

[Acts 12:19] And when Herod had sought for him, and found him not, he examined the keepers, and commanded that they should be put to death. And he went down from Judaea to Caesarea, and there abode.

[Acts 12:21-23] And upon a set day Herod, arrayed in royal apparel, sat upon his throne, and made an oration unto them. And the people gave a shout, saying, It is the voice of a god, and not of a man. And immediately the angel of Yahweh smote him, because he gave not God the glory: and he was eaten of worms, and gave up the ghost.

That the only naturally born legitimate heir of the dynasty ruling the Roman Empire was the king of Judea is no small matter. It is the source of the greatest lie and the best-kept secret the world has ever known. It is the avowed object of Freemasonry to rebuild the Temple and consecrate it to the Catholic worship, with Jerusalem as the mother-city of the world, and the pope as its king.

Babylon the Great (7 of 40) – The Pantheon

M. AGRIPPA L. F. COS. TERTIUM FECIT

“Built by Marcus Agrippa, son of Lucius, in his third consulate”

Agrippa’s Pantheon in Rome has served as the Catholic replacement for the Temple in Jerusalem since the first century. It was destroyed by fire 10 years after the destruction of Zerubbabel’s Temple, and again by lightning in 110 AD. When it was rebuilt again, the Pantheon was the largest domed structure in the world. It remained so until the modern age of steel reinforced structural engineering.

Since the 7th century the Pantheon has been used as the primary Catholic temple dedicated to the veneration of Mary, the Catholic Isis. It is now called *Santa Maria Rotonda*. A rival basilica was built by Constantine but it too was destroyed, rebuilt, and destroyed again. The Hagia Sophia in Istanbul was built on the same site by the Byzantine emperor Justinian.

The Roman Catholic religion and all its offshoots are continuations of Babylonian sun worship. They have nothing to do with Christianity.

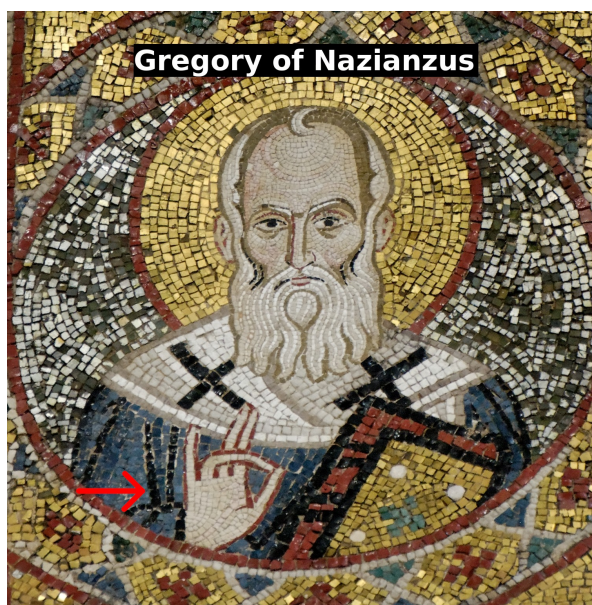




For example, there are no inscriptions pertaining to any form of Christianity on the Arch of Constantine which was erected in celebration of Constantine's victory over the Roman emperor Maxentius. In fact, Constantine actually finished building the Basilica of Maxentius on the Sacra Via while Pagan practices continued, and then he built his own basilica right next to it.

Before the battle of Milvian Bridge where he defeated Maxentius, Constantine looked to the sun and was told *In hoc signo vinces* ('in this sign, conquer'). The sign which he saw was the Chi Rho. Catholicism did not become the state religion of the Roman Empire until the Edict of Thessalonica in February of 380 AD, shortly after the death of the Christian emperor Valens. Later that year Theodosius I came to Constantinople and expelled the Christian bishop, replacing him with Gregory of Nazianzus the "Trinitarian Theologian".

The *prana mudra* is always performed in secret.



In 390 AD Theodosius was excommunicated by Ambrose, the influential Catholic bishop of Milan, for ordering the murder of 7000 civilians in Thessalonica. Among other things, this proves that the primacy of the bishops lay outside of Rome even at the end of the fourth century, and that the claim of supremacy of the pretenders in the West against the pontiffs in the East did not originate in Rome.

Theodosius made peace with Ambrose by turning his attention away from the Christians. Instead, Pagans were massacred by the thousands, and their temples were destroyed. Theodosius appeased Ambrose by disbanding the Vestal Virgins and extinguishing the eternal flame in Rome. Pagan temples were converted into churches, and *mithraea* into crypts.

There are over 200 churches in the city of Rome alone that were built by Pagans. The term 'church' itself refers to the goddess Circe. The Greek word *ekklesia* is used in the New Testament to denote both congregations of Christians and the churches of Pagans. This was well known to the first English Bible translators including Wycliffe and Tyndale, but King James expressly prohibited the correct word from being used in the KJV.

[Acts 19:32] Some therefore cried one thing, and some another: for the **assembly** was confused; and the more part knew not wherefore they were come together.

[Acts 19:34, 37] But when they knew that he was a Jew, all with one voice about the space of two hours cried out, Great is Diana of the Ephesians ... For ye have brought hither these men, which are neither robbers of **churches**, nor yet blasphemers of your goddess.

[Acts 19:39-41] But if ye inquire any thing concerning other matters, it shall be determined in a lawful **assembly**. For we are in danger to be called in question for this day's uproar, there being no cause whereby we may give an account of this **concourse**. And when he had thus spoken, he dismissed the **assembly**.

The goddess referred to here is Diana, the patron of Ephesus. The temples of Diana were called churches because Diana was the Roman version of the Greek Artemis. In another form she was worshiped as Ceres or Circe. The word 'circle' comes from Circe: church = circle.

Proserpina = Persephone = Ceres = Circe

Persephone/Isis = queen of the underworld
Hebat/Ishtar = queen of heaven

Diana is the moon goddess. The Catholic Mary is depicted as standing on a moon crescent.

Santa Maria Rotonda = Holy Mary Circle = Holy Church of the Great Mother

The reason the Pantheon is called 'all gods' is that Roman Catholicism is a syncretic religion. These gods are all derivations of the same Babylonian deities, the so-called fallen angels. The Greeks knew it, the Romans knew it and the Pope *knows* it. Why didn't you? Could it be because you were listening to the lies they have been telling you?

Babylon the Great (8 of 40) – A New World Order

[Matthew 24:15-16, 21] When ye therefore shall see the abomination of desolation, spoken of by Daniel the prophet, stand in the holy place, (whoso readeth, let him understand:) Then let them which be in Judaea flee into the mountains ... For then shall be great tribulation, such as was not since the beginning of the world to this time, no, nor ever shall be.

Imagine a Roman emperor as pope in Jerusalem. It has already happened, and it will happen again.

Nero's own wife worshiped in a synagogue. Is it any wonder he murdered her too?

A power that ruled without antagonism and without concurrence, and consequently without control, proved fatal to the Sacerdotal Royalties; while the Republics, on the other hand, had perished by the conflict of liberties and franchises, which, in the absence of all duty hierarchically sanctioned and enforced, had soon become mere tyrannies, rivals one of the other. To find a stable medium between these two abysses, the idea of the Christian Hierophants was to create a society devoted to abnegation by solemn vows, protected by severe regulations; which should be recruited by initiation, and which, sole depositary of the great religious and social secrets, should make Kings and Pontiffs, without exposing it to the corruptions of Power. In that was the secret of the kingdom of Jesus Christ, which, without being of this world, would govern all its grandeurs.

This idea presided at the foundation of the great religious orders, so often at war with secular authorities, ecclesiastical or civil. Its realization was also the dream of the dissident sects of Gnostics or Illuminati who pretended to connect their faith with the primitive tradition of the Christianity of Saint John. It at length became a menace for the Church and Society, when a rich and dissolute Order, initiated in the mysterious doctrines of the Kabalah, seemed disposed to turn against legitimate authority the conservative principle of Hierarchy, and threatened the entire world with an immense revolution.

The Templars, whose history is so imperfectly known, were those terrible conspirators. In 1118, nine Knights Crusaders in the East, among whom were Geoffroi de Saint-Omer and Hugues de Payens, consecrated themselves to religion, and took an oath between the hands of the Patriarch of Constantinople, a See always secretly or openly hostile to that of Rome from the time of Photius. The avowed object of the Templars was to protect the Christians who came to visit the Holy Places: their secret object was the re-building of the Temple of Solomon on the model prophesied by Ezekiel.

This re-building, formally predicted by the Judaizing Mystics of the earlier ages, had become the secret dream of the Patriarchs of the Orient. The Temple of Solomon, re-built and consecrated to the Catholic worship would become, in effect, the Metropolis of the Universe; the East would

prevail over the West, and the Patriarchs of Constantinople would possess themselves of the Papal power.

The Templars, or *Poor Fellow-Soldiery of the Holy House of the Temple* intended to be re-built, took as their models, in the Bible, the Warrior-Masons of Zorobabel, who worked, holding the sword in one hand and the trowel in the other. Therefore it was that the Sword and the Trowel were the insignia of the Templars, who subsequently, as will be seen, concealed themselves under the name of Brethren Masons.

To acquire influence and wealth, then to intrigue, and at need to fight, to establish the Johannite or Gnostic and Kabalistic dogma, were the object and means proposed to the initiated Brethren. The Papacy and the rival monarchies, they said to them, are sold and bought in these days, become corrupt, and to-morrow, perhaps, will destroy each other. All that will become the heritage of the Temple: the World will soon come to us for its Sovereigns and Pontiffs. We shall constitute the equilibrium of the Universe, and be rulers over the Masters of the World.

The Templars, like all other Secret Orders and Associations, had two doctrines, one concealed and reserved for the Masters, which was Johannism; the other public, which was the Roman Catholic. Thus they deceived the adversaries whom they sought to supplant. Hence Freemasonry, vulgarly imagined to have begun with the Dionysian Architects or the German Stone-workers, adopted Saint John the Evangelist as one of its patrons, associating with him, in order not to arouse the suspicions of Rome, Saint John the Baptist, and thus covertly proclaiming itself the child of the Kabalah and Essenism together.”

Babylon the Great (9 of 40) – The Papacy

Eusebius recorded Constantine's vision as happening before the war with Maxentius had even begun. The *Labarum* (Chi Rho) is supposed to be a Christian symbol. Is it? These regalia are called the *heka* (crook) and the *nekhakha* (flail or flabellum). The crook is a curved staff used for steering sheep who stray too far from the herd. Protestant Christian ministers are called 'pastors' (shepherds, sheep herders). The Egyptian hieroglyph for 'flail' is 'rule.' This symbol still figures prominently in Freemasonry. These regalia symbolize both spiritual and temporal authority to rule as God on Earth.



Andjety (Osiris) was the god-king of the antediluvian world. He was depicted as holding the crook and flail, and Egyptian kings beginning with Nimrod (Horus) held them as symbols of authority, claiming to be his heirs and reincarnations. Egypt was the land of Osiris. No god-king could claim to be his successor without first conquering Egypt. It is no coincidence that the Roman Empire came into existence when Agrippa defeated Antony and Cleopatra in 30 BC, abolishing 3000 years of Egyptian hegemony and nearly 500 years of dominance by the Senate in Rome.

Ptolemy was murdered there when he sought to legitimize the Senate's war with Caesar. Caesar went on to depose Ptolemy XIII, but relinquished the monarchy to his lover Cleopatra, as assuming it would have further alienated him from Rome. Cleopatra also brought Antony to Alexandria and became his lover. From there he captured Jerusalem and installed Herod as the puppet king of Judea. Finally, Octavian had the Senate declare Antony an enemy of the state, and then invaded Egypt. It remained in the hands of the Roman pontiffs, each of whom was deified by the senate, until 383 AD.

When Constantine painted the *labarum* on the shields of his legionnaires, he was claiming divine providence. He was heavily influenced by Lactantius, who was from North Africa, and who also thought the earth is flat. As a "Christian" professor at Nicomedia, Lactantius convinced the emperor to build a new capitol in Byzantium and to hold the first universal synodical convention at Nicaea (Nicomedia). When Constantine was questioned about drawing a line for the new city walls, he claimed that an angel was leading. Apparently Constantine and Lactantius saw things that no one else saw. As it was dedicated, Constantine was crowned tyche (tutelary deity) of the city, wearing the Diadem of Apollo.

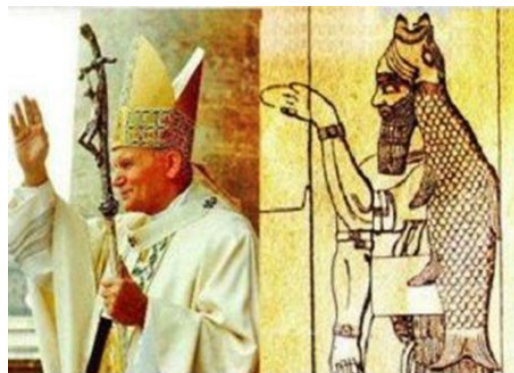
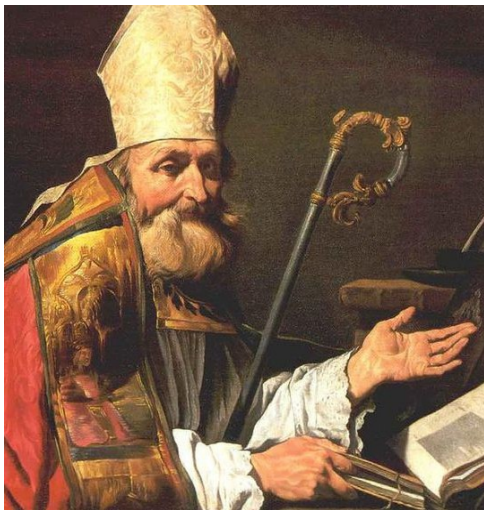
Lactantius also tutored Constantine's firstborn son Crispus. The circumstances of his death are unknown. Crispus was put to death on Constantine's orders shortly after the First Council of Nicaea, probably because he refused to accept the new state religion. Constantine's wife Faustus was also murdered because she was a Christian. So were his sister Constantia and her husband, the deposed emperor Licinius I, and their son Licinius II.

This was perfectly in keeping with the precedent of Nero and Caligula. All had embraced Christianity, and historians seem to forget that Constantine's Edict of Milan (313 AD) which proclaimed tolerance of Christianity was issued jointly with Licinius, and that Galerius had issued a similar proclamation two years earlier. The only change which Licinius and Constantine made was to restore property lost to the Christians under the persecutions.

It is thought that Constantine's mother was the one who introduced him to "Christianity." In fact she was a stable maid who wasn't even married to Constantine's father, which made her a whore and Constantine a bastard. It was his idea to kill Fausta. She is a saint now, "equal to the apostles."

The title of *pontifex maximus* was held by the emperors in the East until the death of the Western emperor Gratian, in Lyon, in 383 AD. From then on it was claimed by Ambrose of Milan. Gratian had refused to wear the insignia of his office, and brought it to shame in many ways, including the prohibition of Paganism in 380 AD, but was still deified according to tradition. Ambrose was the author of the doctrines of the virgin birth, and of the immaculate conception of Mary. He was chiefly responsible for the conversion of Rome, where he rededicated the Vestal Virgins to the worship of Mary after convincing Theodosius to undermine their tradition.

Ambrose is often depicted with the crook and mitre, and also the flail and palladium (as shown below). Every bishop of Rome has claimed the title of *pontifex maximus* since 384 AD. This is also when the term 'papa' or 'pope' first came into use.

Babylon the Great (11 of 40) – Where Satan Dwells

According to Roman legend, the Roman civilization was founded by vanquished survivors of the Trojan War led by Aeneas of Dardania. Dardania was the mother of the city of Troy. Its founder was Dardanus, son of Zeus and Electra. Electra's father Atlas is the primordial giant who bears the world on his shoulders to separate the Earth and Sky. Troy takes its name from Dardanus' grandson Troas, whose son Ilus built Ilium. Troas' other sons were Assaracus, who ruled over Dardania when his father died, and Ganymede.

Troas was the great-grandson of Zeus, and the great-great-grandson of Cybele through Dardanus' wife Batea. The Roman patrician families claimed descent from Aeneas, and therefore Zeus and Cybele. Zeus is the "Sky Father" and Cybele the "Earth Mother." Put another way: Zeus is the Sumerian Anu and Cybele is the Sumerian Ki.

Sky Father:

Sanskrit – द्यौष्पितृ (Dyauspitr)

Greek – Ζεὺς πατήρ (Zeus Pater)

Latin – Iuppiter, Diespiter (Jupiter, Dis Pater)

Julius Caesar explicitly claimed descent from Dis Pater in his *Commentarii de Bello Gallico*. The *gens Julia* had long claimed descent from Aeneas' son Ascanius, the founder of Alba Longa, birthplace of Romulus and Remus.

Dardania was supposedly founded upon Mt. Ida. It was said that Aeneas' father Anchises was seduced by Venus at Mt. Ida. Ganymede was abducted by Zeus at Mt. Ida, and Paris, the prince of Troy, was also raised on Mt. Ida before abducting Helen.

The judgment of Paris, which led to the Trojan War, took place at Mt. Ida. It is said by Troy's founder Dardanus was a Tyrrhenian prince. The Romans also referred to the Etruscans as Tyrrhenians, a word which the Greeks used to refer to non-Greeks. This is also the origin of 'tyrant' and 'Tuscany.' The Tyrrhenians were called 'sons of Circe.' *Ida* means 'goddess.'

This word refers to the Mithraic mysteries, which were originally rites of the Cybele cult wherein the initiate bathed in the blood of a sacrificed bull, and was then called *tauroboliat*. The *mithraeum* of Rome was originally known as the *taurobolium*.

The whole world believes that Troy was located at the site of modern day Hisarlik in Turkey. What if it wasn't? What if it was located somewhere else? What if the truth is so compelling that Rome's association with it would be its undoing?

[Revelation 2:13-14, 16] And to the angel of the church in Pergamos write; These things saith he which hath the sharp sword with two edges; I know thy works, and where thou dwellest, even where Satan's seat is ... where Satan dwelleth. Repent; or else I will come unto thee quickly, and will fight against them with the sword of my mouth.

If you want to know where Satan dwells, start seeing pyramids.



Babylon the Great (12 of 40) – The Palladium

[Revelation 2:11] [He that has an ear, let him hear what the Spirit says unto the congregations: He that overcomes shall not be tormented by the second death.](#)

The Trojan religion was based on the Samothrace mystery rites of the son of Zeus and Electra (Dardanus' brother), Iasion. Central to these rites were the Great Mother, identified as Demeter or Cybele, and Hecate, identified as Ceres, Persephone and Aprodite. The world's first Greco-Roman churches were shrines of the Samothrace cult. The influence of Cybele and of the Babylonian religion are clear.

Athena (Minerva) and Nike (Victory) were added to the list of goddesses later. They were closely associated, and often indistinguishable from each other, as Athena was the Greek goddess of war and therefore the personification of victory. Nike was the daughter of the Titan Pallas, whom Athena slew in battle. These goddesses were worshiped with images before they began to take on human qualities. The more powerful images were pillars and meteorites. At Troy, Cybele was worshiped with the image of a meteorite, and Athena with a wooden statue. The statue became known as the Palladium, named after Pallas. It was said to have fallen from the sky when Ilus prayed for protection on behalf of his new city.

The oracles revealed that Ilium would not fall to its enemies so long as the Palladium remained within the city. During the Trojan War it was stolen by Athena's most beloved heroes, Diomed and Odysseus. The Trojan prophetess Cassandra who had predicted the fall of Troy was raped and taken captive in the Temple of Athena.

According to the Roman legend the Palladium was recovered by Aeneas, who brought it to Latium. It was then housed in the Temple of Vesta as the most sacred relic of Rome's ancient past. This supposes that the statue stolen by Diomed and Odysseus was a fake. If it wasn't, then the Greek version of the story contradicts itself, as Cassandra was raped at the feet of the Palladium after the fall of Troy. What the Trojan exiles brought to Latium was not the image of Cybele; it was a statue of a goddess which served as a holy relic. The cult which was built around it was a society of virgin priestesses—the same which was rededicated to Mary by Ambrose of Milan. Although the order of the Vestal virgins was not instituted until the reign of Numa Pompilius, Romulus and Remus were born to a Vestal priestess of Alba Longa who was supposedly seduced by Mars.

Pergamum itself was supposedly founded by the Greek hero Telephus, a son of Hercules by Auge, a priestess of Athena. Telephus became the king of Mysia, married the daughter of King Riam, and aided the Trojans in the war against the Greeks. Telephus did not actually found the citadel of Ilium, but he is accredited with the establishment of the cult of Athena there, as shown on panels 44-46 of the Pergamon Altar.

The Trojans and the Phrygians of Asia Minor practiced the Babylonian animal sacrifice called haruspice (examination of the liver). The Etruscans inherited this ritual, and it was done in Rome until the time of the Christian emperor Gratian (c. 375 AD). Attalus I of Pergamon performed the haruspice before an important battle to secure Pergamon's independence and wrote *Nike* on the liver to boost his army's morale. After the battle a shrine to Nike and the Athenaeum of Pergamon were built on the acropolis. The temple of Asclepius was also at Pergamon.

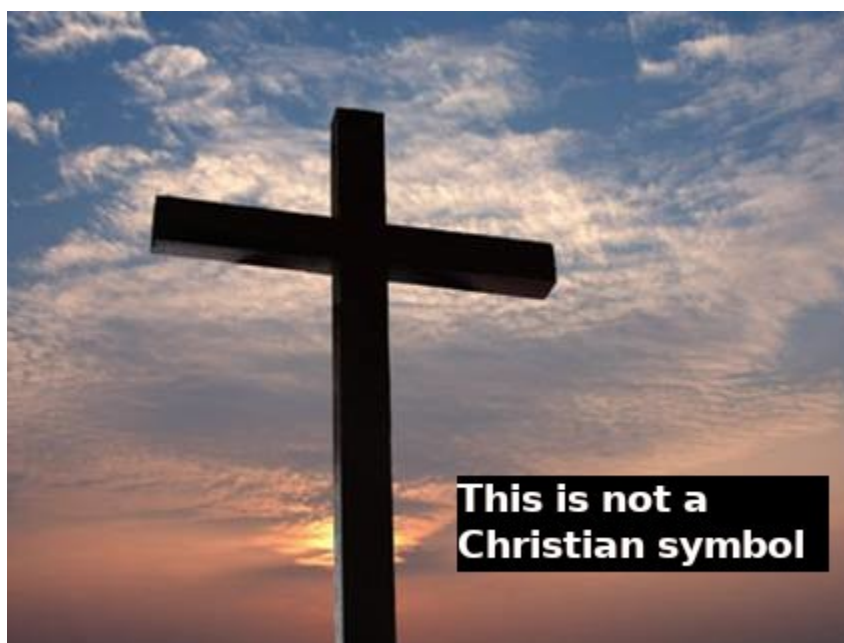
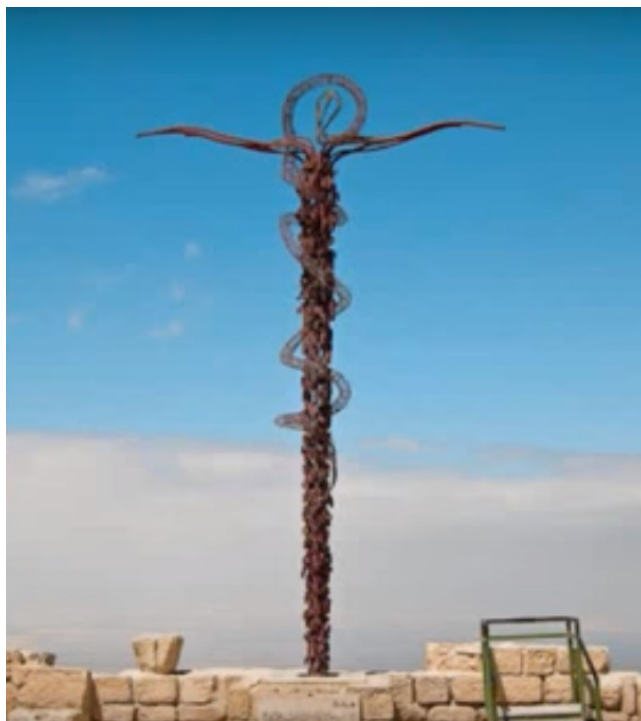
According to the myth, Asclepius was a son of Apollo. His mother was killed for being unfaithful to Apollo. Apollo could not bring himself to kill her, so he had his sister Artemis (Hecate) do it. Asclepius was thought to have raised Hippolytus (Virbius) from the dead at the behest of Artemis, for which Zeus killed him with a lightning bolt. Hippolytus became a deified forest god and went off to live in a sacred grove of Diana in Aricia.

Hippolytus was the first *rex nemorensis*, the one who established the Diana cult in Italy. All Greek and Roman physicians worshiped Asclepius, including Hippocrates.

Babylon the Great (13 of 40) – The Syblis

The recently discovered Athenaeum of Rome was built at the northern point of the Roman Forum, one of the most important locations in the world. The palace on this site has been the residence of several popes, cardinals and ambassadors.

Just south of this is the church of Santa Maria in Aracoeli, which was built over the *auguraculum*, where the augurs who performed the haruspices met, and the *Ara primogeniti Dei* (altar of the firstborn God), where the Tiburtine Sibyl was said to have prophesied the coming of the Christ to Augustus. The altar of the church depicts both the sibyl and the emperor.

‘Sibyl’ is derived from Cybele, and is synonymous with ‘prophetess.’ Unlike the oracles of Greece, the Sibyls are a more dynamic element of Roman religion. They speak for Apollo and Athena.

Commissioned by Pope Julius II, Michelangelo painted the Delphic, Libyan, Persian, Cumean and Erythraean Sibyls on the ceiling of the Sistine Chapel, the personal church of the popes and papal enclaves, alongside the prophets and patriarchs of the Bible. Far beyond the city on the other side of the Tiber, the Sistine Chapel was not built at a random location, but rather on top of Nero’s circus in what is now Vatican City.

The Sibylline Books were composed at Mt. Ida around the time of Daniel’s vision. They served as the basis of the entire Roman religion, except for what the Romans inherited from the Etruscans, from the reign of Tarquinius, Rome’s last king. The Romans consulted the Sibylline Books during times of crisis in order to avoid catastrophes. The patricians who interpreted them gave orders to the Senate, which led to the creation of each of the state temples and religious observances.

In 205 BC Hannibal Barca was in Italy and all hope for Rome’s future seemed lost. The Books were consulted, and as a result the Senate sent Publius Cornelius Scipio to the Kingdom of Pergamum to bring back an image of Cybele. He did, and upon his return the cult of *Magna Mater Idaea* (Great Mother of Ida) was established. Within a few years Scipio went on to attack Carthage and defeated Hannibal. In exile, Hannibal was given command of a Seleucid fleet against Pergamum. He was defeated, so Scipio’s army came to Anatolia where they defeated the Seleucids. The Roman victors demanded Hannibal be turned over to them, so he went into exile again and served the king of Bithynia against Pergamum again, before finally committing suicide.

The wars between the Romans and their Eastern enemies were continuations of the Second Punic War and the hunt for Hannibal, but they were also aimed at protecting their ancestral homeland and vouchsafing the relics of their old religion. An agreement was reached between Rome and Pergamum; the Attalids were given control of Anatolia, and the Kingdom of Pergamum was eventually bequeathed to the Senate and people of Rome, essentially forming a union of the two states.

During the Mithridatic Wars with the Kingdom of Pontus, Rome formed a similar alliance with the Kingdom of Bithynia. Just after the Second Mithridatic War the Sibylline Books were destroyed in a fire, and the Senate sent emissaries to fetch replacements for them. When they returned the wars resumed, and Pontus was finally defeated. Bithynia was also bequeathed to the Senate, and its religion incorporated into the state religion. The Roman legionnaires were initiated into the Mithraic mysteries which, unlike the Samothrace mysteries, were exclusive. These soldiers were called the *militia dei* (‘Army of God’), and were the predecessors of the Society of Jesus.

Babylon the Great (21 of 40) – The Crown

Before we go on, a few things need to be explained so that the significance of place names will be apparent. Let's begin to examine how the City of London became the financial capital of the world, and the connections between the banks in England with Roman Catholicism. To do this we'll need to understand the Reformation in England, the nature of the Catholic veneration of Mary, the origins of the True Cross, and the relationship between the Great Mother and Sun.

Those contemporary authors who have kindled interest in ley lines and sacred geometry have established Glastonbury as the capital of the New Age. This is partly due to their understanding of the geomantic grid, and partly to the fact that King Arthur, that "once and future king," is supposedly buried at Glastonbury Tor. The legend of King Arthur and the prophecy of his return to rule is a blatant transportation of the Osiris cult in the British Isles. It was invented by monks from Glastonbury as the Avalon of the medieval Arthurian legends.

Glastonbury Abbey is supposedly the oldest church in the world, having been founded by Mary's uncle Joseph of Arimathea who brought the Holy Grail to Britain. Several kings were buried here prior to the Norman conquest, and at the time of the Dissolution of the Monasteries it was the second wealthiest abbey in England next to Westminster. The Dissolution was the result of the Reformation of the Church of England led by Henry VIII and his daughter Elizabeth I.

Henry only made one pilgrimage in his whole life, which was with his wife Catherine of Aragon, to Walsingham. Catherine is buried here, and so was Mary, Queen of Scots, before her interment at Westminster. Considering Peterborough's relative obscurity, there is only one possible explanation for this. Both of these women were devoutly Catholic, and both were icons of Rome at the height of the English Reformation.

The cathedral in Peterborough is the nearest one to Walsingham, where Catherine devoted herself to Mary. After failing to produce a male heir, Henry sought a divorce from Catherine and then an annulment. Catherine was deeply religious, a daughter of Ferdinand and Isabella and aunt of the Holy Roman Emperor. The Church had no interest in granting Henry's request. Henry went ahead with the annulment anyway, alienating England from the entire Catholic world. He was recognized as the supreme governor of the Church of England by an act of Parliament in 1534, and the Dissolution of the Monasteries began in 1536. Church possessions were confiscated by the Crown, and Henry created the Court of Augmentation (a precursor to HM Revenue) to administer them. The annual wealth gained by the Crown from the confiscated land had the value of over £60 million. Many of these lands were sold off, and the great monasteries fell into disrepair.

Contrary to popular belief, as in the case of the Federal Reserve and the Internal Revenue Service in America, HM Revenue and Customs is endorsed by, but is not actually a department of the British government. It is a law enforcement agency of the Crown. Its logo is St. Edward's Crown, which replaced the Tudor Crown in 1953. It carries on the executive orders of the legal district of the City of London known as the Temple (so named because it was the headquarters of the Knights Templar in England).

The Society of Jesus was created in 1534 to combat the Protestant heretics, particularly in Britain. The reconquest of Britain was accomplished by the Jesuit William Laud who became Bishop of Bath and Wells (Glastonbury), Bishop of London, and Chancellor at the universities at Oxford and Dublin. Laud's influence as Archbishop of Canterbury led to the settlement of Puritans seeking religious

freedom in America. Despite his beheading for his treason, his liturgy is still used by the Churches of Scotland and England. Despite his influence, the Mary cult was suppressed. Elizabeth styled herself 'the Virgin' to replace Mary in the minds of the mob.

Pilgrimages to Walsingham finally resumed in 1897 when Slipper Chapel was reconsecrated to Catholic use. Pope Leo XIII sent a statue of Mary from Rome and it was enshrined at King's Lynn in Norfolk (the parish of Walsingham).

Anyone who doesn't know that Catholics worship Mary hasn't paid any attention to what's going on all around them. Any Catholic who denies it is a liar and an antichrist.

These and many other words spoken at masses throughout the year, with their exact equivalents in ancient languages, have very deliberate meanings dating back to Nimrod. As the Roman Catholic Artemis/Circe/Persephone, Mary is associated with the month of May, which is named after and dedicated to her.

The mood of springtime informs the church's interior; nature's blossoming, the warm air of May evenings, human gladness in a world that is renewing itself—all these things enter in. Veneration of Mary has its place in this very particular atmosphere, for she, the Virgin, shows us faith under its youthful aspect, as God's new beginning in a world that has grown old.

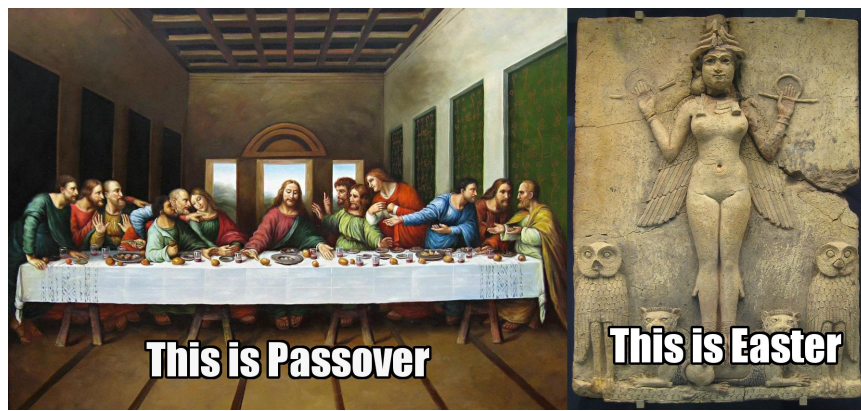
Mother's Day is celebrated on the second Sunday of May. The Feast of the Visitation is May 31 (Memorial Day in the United States). The Feast of the Cross (Crouchmas, or Roodmas) is May 3. (Constantine's mother supposedly discovered the True Cross in Jerusalem on May 3, 355 AD).

Catholics are encouraged to recite "May Devotions" to Mary both in May and October. The first apparition of Our Lady of Fatima occurred on May 13, 1917. Every year crowds of up to a million Catholic pilgrims gather in Fatima to pray to Mary on May 13 and October 13.

Pope Pius XII issued the *Ausipica Quaedam*, requesting worldwide prayers to the Virgin, as well as the consecration of all Catholics to the Immaculate Heart, on May 1, 1948. His encyclical *Ad Caeli Reginam* officially established Mary as the Queen of Heaven, contrary to the claim of many Catholic apologists.

Several popes have made pilgrimages to Fatima. John Paul II credited Our Lady of Fatima for saving his life on the Feast of Our Lady, May 13, 1981. The following year he brought the image of Our Lady of Walsingham to England, effectively rededicating Great Britain to the Catholic worship for the first time since Henry VIII had visited Walsingham Abbey.

May day is now celebrated on the first of the month in Ireland, and the first Monday in the United Kingdom. It is a bank holiday in the UK. When the Bank Holidays Act was passed in 1871 there were only four bank holidays: Easter (Ishtar/Isis) Monday, Whit Monday (first Monday in May), the first Monday in August (a pan-European holiday) and Christmas (winter solstice). Other bank holidays include the last Monday in August and the last Monday in October. Monday is essentially Mary's day, as Diana is the Roman moon goddess. In 2010, 6 out of 10 bank holidays fell on a Monday. The Act of Union which formally united the kingdoms of England and Scotland was passed on May 1, 1707. The Illuminati recognize May 1, 1776 as the date of the establishment of their order.



St. Walpurga was an English missionary to the Franks, who associated her with their Earth Mother. Her feast day is May 1. The Pagan customs of Walpurgis Night (April 30-May 1) were brought to England by the Angles and Saxons, including the crowning of a May Queen, and festivities surrounding a Maypole. These customs are still practiced by Catholics and Pagans around the world. As symbols of Cybele, maypoles were originally in the form of a cross. They were made from hawthorn wood.

Babylon the Great (22 of 40) – The Whore

Nimrod's historical Akkadian title was Sargon ('the legitimate king'). The ziggurats of Babylon were built to replicate the pyramids of Giza which they were built by his "father" Osiris. He was a patron of the Sumerian goddess Inanna, his "mother." Nimrod is the veritable Antichrist, the one worshiped by all Catholics and "Christians" as the Son of this Trinity.

Here is her consort Tammuz/Dumuzi, a.k.a Baal, Osiris, Adonis, the LORD, etc.

Inanna was the daughter of the Sky Father, Anu, and the moon goddess Ningal ('the Great Lady'). Her name is an abbreviated form of Ninanna, which means 'Lady of An,' or 'the Queen of Heaven.' She is the mistress of nature, and therefore of wild beasts. Like Cybele, Inanna is often depicted on a lion. The whore of John's apocalypse does not ride a bull; she rides a beast.

Nimrod was a "mighty hunter" against Yahweh. Inanna is a huntress. As the goddess of erotic love, Inanna was incorporated into the Greek pantheon as Aphrodite, and into the Roman pantheon as Venus. However, as the goddess of fertility and war, she is also the archetype for the other pre-Hellenic goddesses such as Minerva/Athene, Demeter/Ceres, and Diana/Artemis.

Every major goddess of the Babylonian-Roman religion is derived from Inanna. She is the Great Mother, the Great Goddess, Mother Earth, Mother Nature, Gaia, and the Queen of Heaven.

You see me here, Lucius, in answer to your prayer. I am Nature, the universal Mother, mistress of all the elements, primordial child of time, sovereign of all things spiritual, queen of the dead, queen also of the immortals, the single manifestation of all gods and goddesses that are, my nod governs the shining heights of Heavens, the wholesome sea breezes. Though I am worshipped in many aspects, known by countless names ... some know me as Juno, some as Bellona ... the Egyptians who excel in ancient learning and worship call me by my true name ... Queen Isis.

By the time this goddess made her way to Rome she was known as Rhea. The Greek name of Rhea only fell out of use when the cult of *Magna Mater* was established, but the Greeks saw no difference between the Anatolian Cybele and their own Rhea. The goddess Rhea was the daughter of Uranus, just as Inanna was the daughter of Anu. Uranus is the Latin Anu.

This is because the first gods (the Titans) were merely the personifications of earlier ideas. As the forms of these deities have become more and more tangible, the true meanings behind the symbols and rituals of religious observance have become lost to all but the initiates of the mysteries.

The name of Yahushua's mother was Miriam, or Miryam (Strong's H4813). In Greek this is Μαρίαμ.

The word 'ma' means 'mother' in all Indo-European languages, as well as Sumerian. Inanna was called *mami* ('mother') and *digner-mah* ('great goddess') before she was called Inanna. In Anatolia, she was called "Ma, mother of the gods." The Latin word for 'mother' is *mater*. Mary is called *Mater Dei*, the 'Mother of God.'

Rome's founder Romulus was worshiped as a god under the deified name of Quirinus. The mother of Romulus and Remus was called Rhea Silvius, which means 'Rhea of the woods,' (i.e. Diana).

Babylon the Great (23 of 40) – Greece

Saturn and Rhea were worshiped in the Olympian pantheon as Zeus and Hera. Zeus is therefore the anthropomorphic Kronos/Ouranos, and Hera is the anthropomorphic Ops/Rhea. These two gods were worshiped together by the Dorian Greeks as the king and queen of Olympus, or heaven. Artemis was worshiped at Lacedaemon (Sparta), the most influential city of the Peloponnesus. Other important Dorian cities included Argos, Rhodes, Halicarnassus, Syracuse and Corinth. The rest of the Greeks worshiped Athena and Apollo together, whether or not they also revered Zeus and other Olympians.

The founding of Greece is directly related to the founding myths of Egypt and Troy. The names to the heroes in the pre-Homeric Greek mythology correspond to tribes, just like those of the Table of Nations in Genesis do. The names of the gods represent natural elemental spirits, and also the Irinim adopted from the Sumerian pantheon. For example, Nilus is the Nile River, and Apis is the embodiment of Osiris, the sacred solar bull which corresponds to the Utu of Sumer and Marduk of Babylon.

The history of Greece begins with the founding of Argos after the flood by Phoroneus, or Fire-Bringer, whose worship there is the origin of the eternal flame. Phoroneus is sometimes regarded as the father of Apis, and sometimes as the father of Pelasgus. Pelasgus is an eponymous name for the inhabitants of Greece prior to the arrival of the Hellenes. It is given to the founder of Argos in some versions, and to the king of Argos who welcomed Danaus to Greece in others.

Argos is the mother-city of Greece. The kings of the major city states were descended from the kings of Argos. It was still one of the most important cities in Greece long after the arrival of the Hellenes (Achaeans, Dorians, Ionians and Aeolians). Homer refers to the Greeks as Argives and also as Δαναοί (*Danaoi*, Danaans) and Ἀχαιοί (*Akhaioí*, Achaeans). ‘Danaans’ is used as a tribal affiliation, designating the tribe of Dan in Greece. ‘Achaeans’ is from Achaea, the name given to the land around Argos.

Danus was the eponymous leader of the Danaans who took his daughters, the Danaides, to Greece, where he re-founded the city of Argos. He was a son of Belus (Canaan) and brother of Aegyptus (Egypt) who fled from Egypt after refusing to marry off his 50 daughters to his brother’s 50 sons, who then proceeded to kill them when they chased them to Greece. This is a retelling of the events of Exodus. Only one of the Danaides didn’t kill her groom, and together they became the ancestors of the kings of Argos, and of the Mycaenean civilization.

The Greek version of the founding myth of Egypt begins when Io, a priestess of Hera at Argos, is seduced by Zeus and turned into a cow to protect her from Hera. She became the mother of Apis who, as the embodiment of Osiris in Egyptian mythology, is none other than Nimrod. Apis married Memphis, after whom the new capital of Egypt under Nimrod was named by the Greeks. Their daughter Libya was the mother of Belus, and also of Agenor. Apis was worshiped as the sacred bull of Egypt.

The name of Agenor in Phoenician (and Hebrew) is *khna*, or Canaan. Agenor was the king of Tyre (and therefore the Lucifer of the Bible) and the father of Cadmus, whose name in Phoenician (and Hebrew) means ‘the East.’ Hermes was worshiped by the name of Cadmus on Samothrace. Cadmus and his brothers Cilix, Thasus and Phoenix were sent by their father to bring back their sister Europa after Zeus transformed into a bull and took her away. They were told not to come back without her but never managed to find her, so each settled in another location and became the eponymous founder of another

civilization—Thasus on the island of Thasos, next to Samothrace, Cilix at Cilicia in Turkey, and of course Phoenix is Phoenicia.

Cadmus journeyed to Samothrace where he stole Zeus' daughter Harmonia, who was the sister of Dardanus, founder of Dardania, and of Iasion, founder of the Samothrace mysteries which he brought with him to Greece. Cadmus went on to consult the oracle at Delphi and founded the city of Thebes, teaching the Phoenician alphabet to the Greeks.

Europa became the first queen of Crete and the mother by Zeus of Minos, eponymous founder of the Minoan civilization. Like Osiris, Minos was regarded as the judge of Hades, while Europa was worshiped in Phoenicia as Astarte. Her husband was named Aterion, and so was the Minotaur which was the symbol and object of the Utu/Apis/Molekh rites on Crete.

The fledgling Athenian state was forced to provide virgins as tribute to fulfill the need of the sacrifice to the Minotaur until it was slain by Theseus who, upon his return, became the king and great founder-reformer of Athens. Athens is now the largest city and capital of Greece. Over 30 other cities worldwide are nicknamed Athens.

The Truth about the Roman Catholic Church

Traditional Catholics argue that Luciferianism was not established over the Roman Catholic Church until the Second Vatican Council, or perhaps earlier, during the reign of numerous antipopes. Some may trace it to the conquest of Rome in the 19th century, or to the subversive activities of the Jesuits which began during the Counter Reformation. Other Christians, in defense of their own doctrines and traditions, which are all rooted in the Catholic (universal) religion espoused by the Romans at Nicaea, will say that the Church simply lost its way and gradually or suddenly became apostate.

But then, if the Laodicean age had already started, and he wasn't just forecasting the future, why did John call the Roman Catholic Church the "whore of Babylon" in his revelation two and a half centuries before it was established? If the church wasn't corrupt before it became universal, then why didn't all the bishops fight the Luciferian subversion at the Council of Nicaea? If it wasn't apostate to begin with, then why did the Roman Christians accept Constantine's pogrom of Mithras worship? Why didn't they resist like the true believers in the East? Are we supposed to believe that it's all just about Roman greed and papal ambitions, or better yet, that Lucifer is God and the Romans were actually on the right side of their war against the Gnostics and Christians?

If the Romans' suppression of the Christians and their scripture was unwarranted and evil, then didn't the apostasy begin long before the establishment of the Roman Catholic Church, from the second century? Either Irenaeus was the Vicar of Christ, or he was a murderous liar and a charlatan. And the same can be said of every other pope.

If the papacy was antichrist, as all the Reformers claimed, then when did it become antichrist? If the argument of the succession of St. Peter is invalid, then did the Church ever really have any God-given spiritual authority to begin with? Ask any Catholic. The entire notion of papal supremacy rests upon this issue, or so we're told.

The truth is that the lie is much older and more sinister than we've been told. It dates all the way back to the founding of Rome, a thousand years before the founding of Constantinople and the Council of Nicaea. The *collegium pontificum* (College of Pontiffs) was founded by Numa Pompilius, Rome's second king, along with the more famous order of the Vestal Virgins. It was a secret society of influential Roman patricians (nobles) who held all the real political power of the Roman aristocracy behind the scenes.

The actual functions of the College of Pontiffs were never disclosed to the masses. Although a few of the pontiffs did engage in the facade of politics at times, they considered politics a waste of time since politicians did not have any real power, just like now. They were, first and foremost, priests of the Mithraic mysteries which the Romans adopted from the Greeks. Their primary function was to carry out a secret agenda of globalization revealed by Apollo through the rites of the Hermetic mysteries. As the most powerful men in the world, they enjoyed special privileges which no other Roman citizens had. Chief among them was the *pontifex maximus*, a title held by only the most notable Roman patricians such as Julius Caesar. The *pontifex maximus* was elected by the college and appointed all new members.

The Roman Catholic Church's appeals to tradition above the authority of God, of scripture and of prophecy stem not from a pseudo-apostolic succession, but from the unbroken ecclesiastical succession of ancient Rome. The myths of Peter being the "first pope" and of the Donation of Constantine are just ludicrous cover stories. No one at or near the top of the Catholic hierarchy is stupid enough to believe

them. Today the political government and ecclesiastical power of the Church is still concentrated in the College of Pontiffs, now called the College of Cardinals, which has enjoyed unbroken succession and the same aristocratic privileges for 27 centuries. They still espouse the same Mithraic mystery religion and perform the same Babylonian Hermetic rites. Their ancient agenda is still globalization in the fashion of Nimrod's rebellion, now referred to as ecumenism. The only difference is that their internally and secretly appointed leader is called *Il Papa*, the Pope, rather than the *pontifex maximus* or the pontiff (bishop) of Rome. This is because none of the other pontiffs took the Romans' claims of supremacy seriously for about two hundred years, when the title of *pontifex maximus* was officially conferred by Constantine, and the Pope wants to be regarded as not just the bishop of Rome, but of the world. But even then, it was taken by Constantine himself, who declared himself the head of the Church and God's representative on earth.

Catholics who buy into the claim of apostolic succession are actually obligated to declare their fealty to the emperors, or perhaps now the patriarchs of Constantinople, not the Roman bishops. Rome was never the seat of Constantine's government, or any of his successors. What traditional Catholics don't realize is that Vatican II was merely a tangible product of the efforts of the secret society which has always governed the Church to bring it back to its roots after centuries of influence from Christian and quasi-Christian leaders who didn't know what they were doing. The church more closely resembles the intentions of the Roman bishops and emperors now than it did before or after the Reformation.
